Don't Ask, Don't Tell was passed by Congress in 1993. Under this policy, supervisors are forbidden from asking a recruit if they are a


homosexual.

# Public Schools: The New Homosexual Breeding Ground

## New Legislation Gives Homosexual Lobby Unlimited Power

Looking to pervert public schools, Homosexual Congressman Jared Polis (D-CO) introduced a so-called “Student Non-Discrimination Act” (H.R. 4530) intended to “provide protection” for homosexual students.

More aptly named the Homosexual Classrooms Act, this bill will provide Obama’s homosexual “Safe Schools Czar” Kevin Jennings with unchecked and unlimited power to implement his agenda in public schools.

Jennings, founder of the Gay, Lesbian, Straight Education Network and recently linked to the North American Man-Boy Love Association (NAMBLA), will have the power to alter the curriculum of every school child with topics on homosexual sex education.

What may be worse than the “homosexual education” school children will receive is the persecution Christian and pro-family children will face under this act.

### Christian and Pro-Family Students to Face Persecution

Polis’s Homosexual Classrooms Act not only opens the curriculum to the Homosexual Lobby’s influence, but it encourages attacks against students who hold beliefs in opposition to the homosexual lifestyle.

Under this new act, homosexual students will be encouraged to report any and all actions that make them feel even the slightest amount of uneasiness.

Children could find themselves reprimanded, forced through

sensitivity classes, or even sued for damages for something as simple as prayer, a look of disapproval on their faces from seeing two boys kissing in the hall, or refusal to share a restroom with a cross-dressing member of the other sex.

The school environment will be reworked in the Homosexual Lobby’s image to provide additional protective laws for homosexual students while creating a hostile environment for Christian and pro-

family students.

“It is disgusting to think our nation’s school children will be forced by law to accept this perverse lifestyle or face a lawsuit for so-called ‘intolerance,’” said Public Advocate President Eugene Delgaudio.

### Polis and Jennings Fighting to Indoctrinate School Children

At the forefront of this assault on the nation’s public schools are Congressman Jared Polis and “Safe Schools Czar” Kevin Jennings.

Both men are radical homosexual activists who have dedicated their

## Homosexual Lobby Ramping Up For Another Assault

# Homosexual Agenda Part II: The Gay Bill of Special Rights

After ramming Thought Control into law, the Homosexual Lobby is now gearing up for yet another assault on traditional values.

This time they are scheming up ways to sneak Barney Frank's Gay Bill of Special Rights, H.R. 3017, into law, making themselves a protected class with special rights.

Public Advocate and other pro-family groups have defeated this bill year after year, but the Homosexual Lobby has more momentum than ever.

"The Homosexual Lobby could pass the Gay Bill of Special Rights within weeks, that is unless Public Advocate supporters step up efforts to defeat this legislation," said Eugene Delgaudio, President of Public Advocate.

### **Homosexuals Must Be Hired**

The so-called Employment Non-Discrimination Act, better known as the Gay Bill of Special Rights gives homosexuals special hiring privileges.

If allowed to pass, the bill

would force employees to hire homosexuals or face prosecution.

Employers would find themselves unable to fire problem employees who are homosexuals.

But the Gay Bill of Special Rights does not just apply to homosexuals. The bill also applies to cross dressers and so-called "Transgender."

Churches, schools, and daycare centers would all have hiring quotas for not only open Homosexuals but those engaging in all sorts of immoral "alternative lifestyles."

### **Radical Homosexuals Demand Immediate Passage**

The author of the bill, Barney Frank, has been meeting with leaders of the Homosexual Lobby to identify the best strategy to quickly pass the Gay Bill of Special Rights.

The openly homosexual Congressman was recently overheard saying, "I had a meeting last week with the transgender community ... we have agreements

on what can be done."

Frank believes passage of the Gay Bill of Special Rights will happen soon and is a top priority item in the new session.

And now Rep. Frank is pressuring his allies in Congress to pass the Gay Bill of Special Rights to honor the liberal legacy of the late Ted Kennedy.

### **The Back Door Gay Bill of Special Rights**

Under intense pressure from the Homosexual Lobby, Barack Obama has begun enforcing Gay Bill of Special Rights-like hiring policies for the federal government.

The federal Equal Employment Opportunity (EEO) policy now includes homosexuals as a protected hiring class for federal jobs.

To reinforce his allegiance to the Homosexual Lobby, President Obama recently appointed a transsexual to be Senior Technical Advisor to the Department of Commerce.

provisions is a \$1,000+ annual Homosexual Lifestyle Subsidy for same-sex “couples” who choose to share a residence and live together in sin.

While Obamacare would reward homosexual “couples,” it added a Traditional Marriage Penalty, which some legal experts estimate could top \$10,000 per traditional family every year.

But the most depraved provision the Homosexual Lobby has snuck into this bill directly targets America’s children for homosexual indoctrination.

**Sodomy Training Seminars in Schools**

Under the current Obamacare bill, tens of millions of taxpayer dollars would be funneled to radical sex-education programs that are little more than explicit training sessions on depraved homosexual sex acts.

“If the alleged purpose of Obamacare is to keep people

‘healthy,’ then how can Congress possibly justify a program which encourages children to engage in risky homosexual behavior?” asks Public Advocate President Eugene Delgaudio.

When Public Advocate discovered these dangerous anti-family provisions in the Obamacare

Bill, Mr. Delgaudio immediately sounded the alarms and contacted supporters to bring the homosexual paybacks to light.

**Pro-family Americans Halt Obamacare**

“We didn’t waste one second in getting the word out and rallying the troops,” explained Mr. Delgaudio. “In days, we were generating thousands of petitions demanding Congress back off from this blatantly anti-family legislation.”

The effect was noticeable. When pro-family opposition mounted, the Obamacare freight train came to a screeching halt in Congress, thanks in great part to the work of Public Advocate supporters.

“Years of battling the Homosexual Lobby has trained me to anticipate their every move,” said Eugene Delgaudio. “While other pro-family groups watched from the sidelines, Public Advocate stood in the trenches and deserves credit for holding off the dangerous Homosexual Healthcare Payback.”

Neil Clark Warren and his wife Marylyn joined in holy matrimony over 51 years ago.

Warren describes his marital success as pure luck, but he didn’t want his daughters to have to take the chance.

For 35 years, Warren studied what makes for healthy marriages so he could help people start healthy families. His goal was to reduce the divorce rate in America by 1%.

“The marital deterioration rate in America, if we don’t bring it under control, will destroy our society. 70% of all persons in our

country have experienced a broken home. Kids are being devastated by this epidemic,” said Warren.

Today, on average, 236 couples marry matches they met on eHarmony every day. And those couples are far less likely to ever divorce.

Warren’s goal of restoring traditional marriage and family values in America did not include homosexual matchmaking.

## Homosexual Agenda Blocked in Key States

### Maine Says "NO" to Homosexual Agenda

Fueled with millions of dollars from millionaire homosexual

activist Tim Gill and others, the Homosexual Lobby bullied and bribed the Maine legislature into passing homosexual "marriage."

When the homosexual "marriage" bill was signed into law by Governor John Baldacci, a pro-family backlash erupted.

Pro-family supporters across the state were outraged that their state representatives ignored their citizens.

On November 3rd, a ballot referendum repealing the same-sex "marriage" law passed easily, restoring traditional marriage in that state. The tide was beginning to turn in the Northeast.

In the months following the Maine Citizen's Veto, homosexual marriage legislation was pushed in both New Jersey and New York, as part of the Homosexual Lobby's ongoing campaign to turn the Northeast into a pro-homosexual

opposed allowing homosexuals to serve in the military.

24% of soldiers said they would leave, or consider leaving the service should gays be allowed to serve.

Soldiers are forbidden from speaking out on this issue, so the Homosexual Lobby is able to spread the propaganda while soldiers are silenced.

The radical Homosexual Lobby does not care about the ability of the armed forces to serve as an effective fighting force dedicated to protecting freedom.

“Soldiers fighting in combat should not have to worry about exposure to AIDS, sexual harassment and being forced to accept homosexual advocacy,” argued Public Advocate President

“There are six places in the Bible that say homosexuality is wrong,” said Warren.

Warren was interested in researching traditional marriages and has little data on homosexual relationships and no interest in supporting immoral lifestyles.
