

# **20 PUBLIC ADVOCATE AMICUS BRIEFS – 2024-2025**

## **1. NRA v. Vullo**

U.S. Supreme Court - Merits (January 16, 2024) Decided 9-0, May 30, 2024. - **Successful**

## **2. Trump v. Anderson**

U.S. Supreme Court - Merits (January 18, 2024) Decided 9-0, March 3, 2024 - **Successful**

## **3. Murthy v. Missouri**

U.S. Supreme Court - Merits (February 9, 2024) - **Unsuccessful**

Missouri and Louisiana challenge to Biden Administration pressuring social media to censor particular speakers and stories (e.g. Hunter's laptop; COVID, etc.). Decided 6-3, June 26, 2024 (denying standing)

## **4. Parents Protecting Children v. Eau Claire Area School Dist, WI.**

U.S. Supreme Court - Petition (July 8, 2024) - **Unsuccessful**

Supporting parents challenging a school district policy that assists children with sexual transitioning without telling the parents of those children. Certiorari denied December 9, 2024; Kavanaugh would grant; Alito & Thomas dissent

## **5. Little v. Hecox**

U.S. Supreme Court - Petition (August 14, 2024) – **Pending hearing**

Supporting the Idaho Fairness in Women's Sports Act to protect women's sports.

## **6. West Virginia v. B.P.J.**

U.S. Supreme Court - Petition (August 15, 2024) – **Pending hearing**

Supporting the West Virginia legislature's efforts to protect girls sports from unfair and potentially dangerous competition from biological men.

## **7. Crouch v. Anderson**

U.S. Supreme Court - Petition (August 28, 2024) - **Successful**

Appeal of 4th Circuit decision ordering West Virginia Medicaid to pay for gender transition procedures.

## **8. Tennessee v. Cardona**

U.S. Court of Appeals for the Sixth Circuit (September 3, 2024) - **Successful**

Challenge to U.S. Department of Education April 29, 2024 Final Rule which directed that discrimination under Title IX includes LGBTQ+.

## **9. Doe v. Ladapo**

U.S. Court of Appeals for the Eleventh Circuit (September 4, 2024) - **Pending**

Defending a Florida statute designed to protect minors from transgender procedures, exposing transgender advocacy of the World Professional Association for Transgender Health (WPATH), & defending state legislators' right to reference God.

## **10. Louisiana v. Department of Education**

U.S. Court of Appeals for the Fifth Circuit (September 26, 2024) - **Pending**

Challenge to U.S. Department of Education April 29, 2024 Final Rule which directed that discrimination under Title IX includes LGBTQ.

## **11. United States v. Skrmetti**

U.S. Supreme Court - Merits (October 15, 2024) - Decided 6-3, June 18, 2025 - **Successful**; Argued December 4, 2024 Defending a Tennessee statute designed to protect minors from transgender

procedures, exposing transgender advocacy of the “World Professional Association for Transgender Health” (“WPATH”), and showing massive profits of transgender medical industry.

**12. Kansas v. Department of Education**

U.S. Court of Appeals for the Tenth Circuit (October 16, 2024) - **Successful**

Challenge to U.S. Department of Education April 29, 2024 Final Rule which directed that discrimination under Title IX includes LGBTQ+.

**13. United States v. Trump U.S. Court of Appeals for the 11th Circuit (November 1, 2024) – Successful**

**14. Petersen v. Doe**

U.S. Supreme Court - Petition (November 21, 2024) – **Unsuccessful**

Defending the Arizona Save Women’s Sports Act.

**15. Free Speech Coalition v. Paxton**

U.S. Supreme Court - Merits (November 22, 2024) - **Successful**

Argument January 15 Defending the Texas law requiring age verification on porn sites.

**16. Parents Defending Education v. Olentangy Local School District - Pending**

U.S. Court of Appeals for the 6th Circuit (Filed December 18, 2024)

School district requires using pronouns of trans kids

**17. L. M. v. Town of Middleborough, MA**

U.S. Supreme Court - Petition (Filed December 20, 2024) - **Unsuccessful**

School banned student from wearing shirts that said “There are only two genders” and “There are [censored] genders”

**18. US v. Shilling**

Brief filed in the U.S. Supreme Court on May 1, 2025. - **Successful**

Brief supports President Trump's Executive Order banning transgenders in the U.S. Armed Forces. We filed the only brief supporting the President's Executive Order. Court ruled 6-3 to uphold Trump EO.

**19. Mahmoud v Taylor**

We filed two briefs in this case - Petition on October 16, 2024 and Merits on March 10, 2025 - **Successful**

Mahmoud case is the challenge brought by parents in Montgomery County to the School Board's refusal to tell parents about, and allow parents to opt out of, LGBTQ+ training. The parents lost in district court in Maryland and in the leftist Fourth Circuit. Justices discussed April 22 at Hearing School Board forcing homosexual propaganda on children as young as 3 years old.

**20. Wilcox v. Trump**

We filed a brief to uphold Trump Administration firing of Gwynne Wilcox from the NLRB and other federal employees. The orders of the district court are stayed pending further order of the court. –

**Successful**
