## It's a Pro-Family Mandate!

### America Rejects Homosexual Agenda



**President Barack Obama, Senate Majority Leader Harry Reid, and the Homosexual Lobby were clear losers in the midterms.**

November 4th's Midterm elections were a historic wave for pro-Family Republicans.

In record numbers, voters across the country rejected candidates who sought to continue the Homosexual Lobby's war on Real Marriage and Religious Liberty.

When the dust finally settled, Democrats had lost control of the Senate with the lowest share of Congressional seats (186) since World War II.

These results were a clear repudiation of the radical agenda

of Harry Reid, the Homosexual Lobby, and Barack Obama.

#### **Gay Bill of Special Rights Dooms Candidates**

Four incumbent Senators who cosponsored the Gay Bill of Special Rights failed to win re-election to the Senate.

Mark Begich (D-AK), Kay Hagan (D-NC), Mark Pryor (D-AR), and Mark Udall (D-CO) were sent packing by voters for their role in passing the Gay Bill of Special

## Homosexual Lobby's Best Chance to Strike

### Grave Dangers Looming in the Lame Duck

The 2014 midterm elections have left the Homosexual Lobby reeling, desperate, and cornered.

Senators Mark Udall (D-CO), Kay Hagan (D-NC), and Mark Pryor (D-AR) -- all of whom co-sponsored and voted for the Gay Bill of Special Rights (S 815) -- lost re-election to the U.S. Senate.

In the House, seven co-sponsors of the Gay Bill of Special Rights (HR 1755) also lost their bids for re-election.

But newly elected officials won't be sworn in until next year.

And lawmakers who just lost their seats are back in Washington for a "Lame Duck" session of Congress.

Pro-Family supporters now face the threat of politicians who can vote on legislation without the fear of losing re-election.

"And that's exactly what makes their final weeks in power so dangerous," Public Advocate President Eugene Delgaudio warned.

"This is the Homosexual Lobby's best chance to pass the Gay Bill of Special Rights while their allies still control the levers of power," Mr. Delgaudio added.

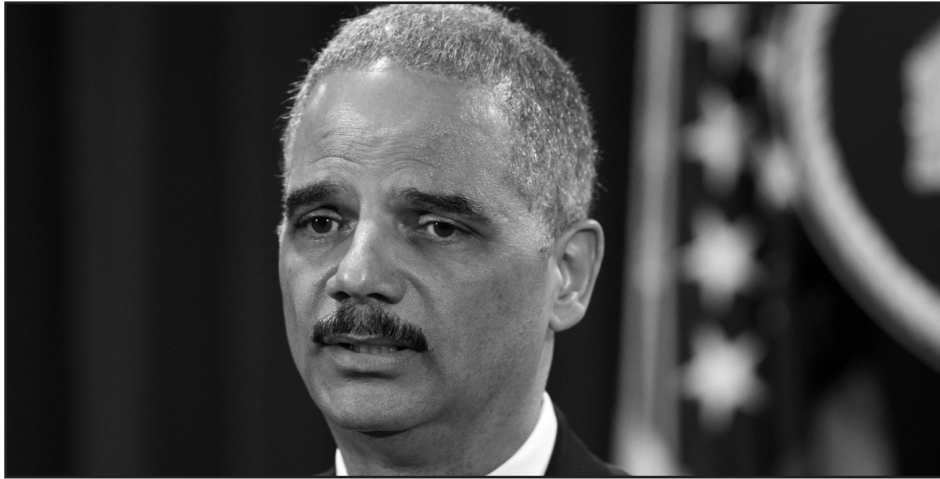

## Eric Holder Finally Resigns

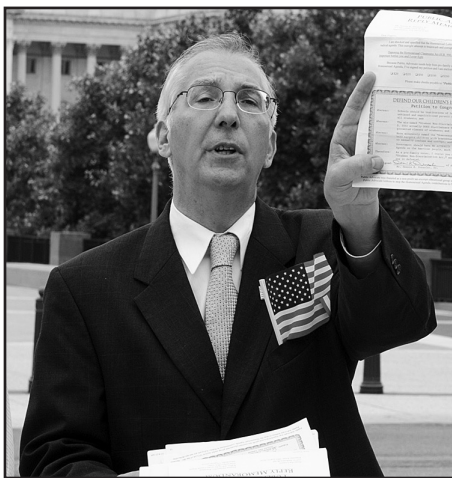


**Anti-Family U.S. Attorney General Eric Holder leaves office.**

After months of Public Advocate's hard-hitting grassroots efforts, rogue U.S. Attorney General Eric Holder announced he will be resigning from his post by the end of the year.

Over the past three years, Public Advocate has gone head-to-head with the Attorney General countless times.

In the spring of 2012, the

Justice Department threatened the University of Arkansas with legal action if the school did not allow a male student to use the women's private facilities -- just because the student claimed to be a woman.

And last year, the Justice Department published mandatory guidelines forcing government employees to endorse the homosexual lifestyle and homosexual "marriage" -- despite religious convictions to the contrary.

This reckless abuse of power prompted Public Advocate to challenge Eric Holder's pattern of lawlessness by launching a national petition drive to impeach him as U.S. Attorney General.

"Attorney General Eric Holder has consistently refused to defend the Defense of Marriage Act before the Supreme Court," Public Advocate President Eugene Delgaudio stated.

"Because of Holder's decision and complete disregard for the law, 19 states have seen their Real

Marriage protections struck down in court," Mr. Delgaudio continued.

### **Public Advocate Fights Back**

Over the past six months, Public Advocate collected and delivered nearly 25,000 petitions to Congress calling for Holder's impeachment.

Public Advocate joined the National March for Marriage in D.C., where we spread the word of Holder's lawless war on Real Marriage and the Family.

Through email and the internet, Public Advocate reached millions of Americans calling for Attorney General Eric Holder's impeachment and detailing his misdeeds.

Public Advocate's unrelenting demonstrations, videos, social network outreach and petitions delivered to key members of Congress pushed Holder to his breaking point.

certain to guarantee defeat of pro-Family candidates all across Michigan.

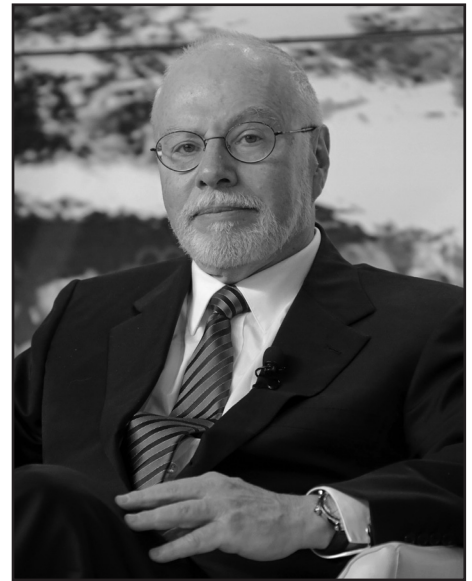
#### Pro-Family Boots On The Ground

Public Advocate recognized the serious threat to the Family and launched a grassroots program to educate voters in Michigan by exposing anti-Family candidates.

Public Advocate launched a hard-hitting campaign of emails, banner advertisements, mail and postcards, phone calls, and even organized a community meeting with pro-Family supporters around the state.

“The Homosexual Lobby spent over \$150,000 trying to take out Pro-Family candidates, and they have nothing to show for it,” Public Advocate President Eugene Delgaudio pronounced.

## 33 States Forced to Comply with Homosexual “Marriage”

# Supreme Court Betrays Real Marriage

An October 6th U.S. Supreme Court decision has forced compliance with homosexual “marriage” on the majority of Americans.

The Supreme Court refused to agree to hear appeals from Virginia, Oklahoma, Utah, Indiana, and Wisconsin.

In doing so, they created the legal precedent to expand so-called homosexual “marriage” by 27 states.

As of this writing, the number of states mandated to recognize so-called homosexual “marriage” stands at 33 states.

### A War on Religious Liberty

This decision has stripped hundreds of millions of Americans of the right to vote their beliefs and protect their communities and families as they see fit.

It is now Supreme Court precedent that Freedom of Speech and the Right to Vote are only recognized so long as they are approved by the Liberal Establishment.

While the legal status of

homosexual “marriage” has reached a record number of states, Public Advocate President Eugene Delgaudio doesn’t plan on giving up the fight to defend Real Marriage.

“We will not surrender the defense of marriage or the right to free speech for Christians and all those Americans who believe in Traditional Values,” said Mr. Delgaudio.

### Public Advocate Fighting Back

Mr. Delgaudio says the key to defending Real Marriage moving

forward is holding U.S. Senators accountable for confirming judicial nominees who support the radical Homosexual Agenda.

“Public Advocate will continue to conduct Senate Candidate Survey programs asking Senators to promise to vote for only judicial nominees who promise to define marriage as between one man and one woman,” explained Mr. Delgaudio.

“And as we saw in the recent midterm elections, those Senators in league with the Homosexual Lobby will be held accountable,” Mr. Delgaudio concluded. 🌱

# School Shuts Down Prayer Group

A high school Christian prayer group in Colorado is the latest target in the Left’s all-out war on Christianity.

Pine Creek High School’s assistant principal went out of his way to target the Christian group because they used their morning free time to pray in an unused choir room.

This harassment was unprovoked, since the group had been peacefully using the room for three years without

incident.

In New York, a small-town Christian couple was fined \$13,000 -- forcing their business to collapse.

And a baker in Colorado was sentenced to mandatory

homosexual re-education classes.

All three cases resulted from Christian business owners refusing to sacrifice their religious convictions.

Public Advocate supporters played a huge role in Eric Holder’s decision to step down as the United States Attorney General,” Mr. Delgaudio declared.

“But resigning his position does not absolve Holder of his crimes against the Constitution and Traditional Values,” Mr. Delgaudio added.

**Eric Holder to be Held Accountable**

The House of Representatives has promised to continue their contempt proceedings against Holder for his role in the “Fast and Furious” gun-running scandal.

“I will continue to push Congress to hold him accountable for his illegal undermining of the

Defense of Marriage Act and state-level Real Marriage laws,” Mr. Delgaudio vowed.

President Obama recently announced Loretta Lynch as Eric Holder’s replacement for U.S. Attorney General.

“I have every reason to believe Ms. Lynch will be an Attorney General who will continue the Obama administration’s war on Real Marriage and Religious Liberty. It’s unacceptable to Public Advocate and pro-Family Americans,” Mr. Delgaudio concluded.

Public Advocate vows to fight any and all attempts by the Obama administration to undermine and destroy religious liberties and Traditional Marriage in the country. 🇺🇸

Rights through the Senate for the first time.

Another incumbent, Senator Mary Landrieu (D-LA), faces severe pro-Family headwinds in her runoff.

But incumbents weren't the only candidates who were sunk for their support for the radical Homosexual Agenda.

Voters in Nebraska, Iowa, and other states rejected Senate hopefuls endorsed by the radical Homosexual Lobby.

### Public Advocate Exposes Anti-Family Votes

The wave that swept away the anti-Family majority in the Senate was triggered in large part by the Senate's passage of the Gay Bill of Special Rights in 2011.

In the aftermath of that vote, Public Advocate sprang into action, exposing the Senators who supported the bill and preventing its passage in the House of Representatives.

Public Advocate's grassroots tactics -- lead by its president Eugene Delgaudio -- immediately alerted constituents of the Senators

who had betrayed pro-Family Americans.

At the same time, Mr. Delgaudio began a sustained campaign targeting Republican leadership in the House to ensure the Gay Bill of Special Rights did not get a vote.

And the efforts paid off.

"Our grassroots programs against the Gay Bill of Special Rights reached millions of pro-Family Americans, exposed anti-Family voting records, and have effectively kept this freedom-killing bill from a vote on the floor of the House," Mr. Delgaudio declared.

### What does the road ahead hold?

The Homosexual Lobby's stranglehold on Congress -- and therefore the judicial confirmation process -- has been severely weakened.

When the new Senate convenes in January, President Obama will have lost the rubber stamp for his

radical judicial nominees.

Under Harry Reid's leadership, judicial activists like Supreme Court Justices Elena Kagan and Sonia Sotomayor were rushed into lifetime appointments and issued rulings that gutted the Defense of Marriage Act and state laws defending Real Marriage.

And if the Republican leadership in the House holds the line against the Gay Bill of Special Rights, it will face a much steeper hurdle in the next Senate under Republican control.

But that does not mean the threat from the Homosexual Lobby can be taken less seriously.

"Given House Speaker John Boehner and incoming Majority Leader Mitch McConnell's willingness to hold votes they know conservatives will lose, it is vital for Public Advocate's supporters to keep their feet to the fire and demand they respect the pro-Family midterm mandate," concluded Delgaudio. 🇺🇸

conservatives to lower their guard in the afterglow of this year's election victories.

If Republican leadership in the House allows the Gay Bill of Special Rights to be attached to "must pass" legislation during the Lame Duck, the Homosexual Lobby may carry enough votes to pass the crown jewel of their radical agenda.

While these measures might seem far-fetched, the threat is very real.

These are the same tactics the Homosexual Lobby employed to pass the chilling Thought Control Act.

### Public Advocate Pressuring Leaders

That's why Public Advocate

budgeted an aggressive lobbying campaign pressuring House Republican Leadership to kill any and all attempts to pass anti-Family legislation.

"With enough pressure, we can force Speaker Boehner and the Republican House leadership to hold the line against the Homosexual Lobby's agenda and to respect the pro-Family midterm mandate," explained Mr. Delgaudio.

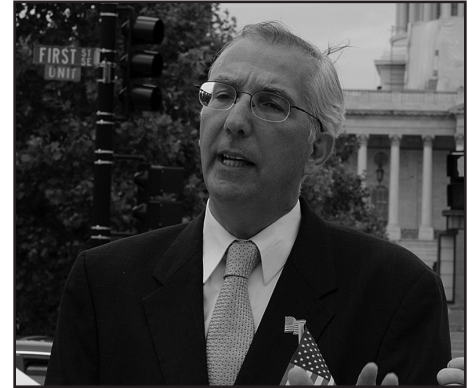
But pro-Family supporters are in for a tough fight.
