## Justice Department Ordered to Defend Religious Liberty

## **U.S. Attorneys Defying Trump**



Public Advocate's have exposed the U.S. Attorneys failure to protect Religious Liberty.

President Trump has fought time and time again to defend Religious Freedom in America.

And since he promised to do so in 2016, the D.C. Swamp has repeatedly undermined and ignored President Trump's orders to defend Religious Liberty.

President Trump issued Executive Order 13798 (May 4, 2017), which was titled "Promoting Free Speech and Religious Liberty," to enforce protections for Religious Freedom.

The 94 U.S. Attorneys were then ordered to designate a "Religious

Liberty point of contact" to lead each office in protecting Religious Liberty.

But Public Advocate made a shocking discovery about the U.S. Attorneys.

### **Fighting for Answers**

In April 2018, Public Advocate filed a Freedom of Information Act (FOIA) request with the DOJ to make sure that the Swamp bureaucracy was actually obeying President Trump.

"A simple FOIA request is nothing special, so you can imagine my surprise when the government failed to answer," Public Advocate President Eugene Delgaudio stated.

"In fact, we received no response

from the government at all until we filed suit in the District of Columbia," continued Mr. Delgaudio.

However, what Public Advocate discovered when the DOJ finally produced the demanded records is troubling.

Out of the 94 U.S. Attorneys' offices, only 20 of them could provide records showing compliance with the President's order -- and three of those only complied after Public Advocate brought suit to get answers.

# Defeating the Entrenched Swamp

It seems that protecting Religious Liberty has not been all that important to the U.S. Attorneys nationwide, and that thought is very troubling," lamented Mr. Delgaudio.

The documents obtained by

Public Advocate demonstrate that, while Religious Liberty protection is important to the President...

... it is not important at all to the U.S. Attorneys' offices around the country.

"Public Advocate's FOIA litigation has shown that government officials cannot be expected to carry out the President's instructions," sighed Mr. Delgaudio.

In the face of this negligence by the U.S. Attorneys' offices, Public Advocate is kick-starting programs to put pressure on them to defend Religious Liberty.

"There are millions of Christians counting on them to do what taxpayers like us pay them to do, and that's following the President's orders," insisted Mr. Delgaudio.

"It's up to pro-Family Americans like us to help President Trump by demanding U.S. Attorneys to take action," Mr. Delgaudio concluded.

# William Barr Exposes the Homosexual Lobby

These shelters are meant to be safe havens for women who have raped.


And even though Dr. Carson's statement did come with good intentions, Radical activists within the HUD instantly turned to the liberal media with accusations against him.

### State Supreme Court Rules In **Favor of Religious Freedom**

After three years, the Arizona Supreme Court ruled that they cannot be forced by the government to make invitations for homosexual "marriages."

However, the Arizona Supreme Court's ruling only applies to this particular business and circumstances.

## **Just The Beginning**

"Any day now, Duka and Koski could be thrown right back into this twilight zone," added Eugene Delgaudio, President of Public Advocate.

"There are still Christians across the country being pummeled by the Homosexual Lobby in a battle to restore their right to Religious Freedom," concluded Mr. Delgaudio.


#### **Judicial Fiat Rules Again?**

"We cannot let those radicals play the same game again with our churches and Pro-Family groups," argued Mr. Delgaudio.


We must stop them here and now," concluded Mr. Delgaudio.
