"But what is terrible news is that so-called 'conservatives' are betraying American families and

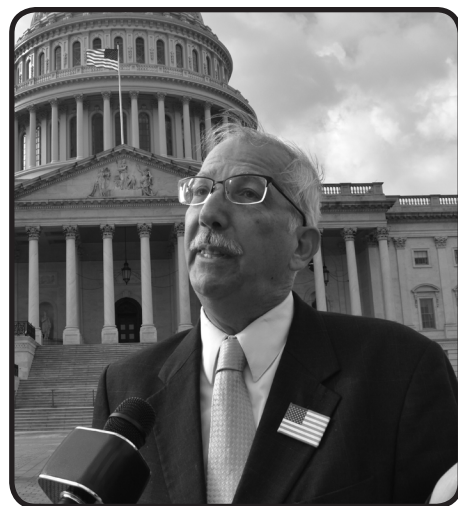
pushing a Trojan Horse bill with the Homosexual Lobby's fingerprints all over it," Mr. Delgaudio continued.

## Public Advocate Takes to the Streets

# Nancy Pelosi Sobriety Checkpoint

Public Advocate volunteers were out in full force at the Capitol again with their trademark street theater earlier this year.

But this time, officials deep within the city's bureaucracy threatened Public Advocate President Eugene Delgaudio and his staff with arrest if they dared to perform a satirical musical demonstration.

For over two decades, Public Advocate has raised awareness about critical issues through the use of public demonstrations and street theater.

### Public Advocate's Impact

For many, the city's sudden reversal and threats are a sign of Public Advocate's impact.

"I think it's clear the Left doesn't want our efforts to succeed, and that's why they've taken this drastic action to suppress your

Public Advocate's right to Free Conservative speech," declared Mr. Delgaudio.

"I know our tactics work, and by banning Public Advocate's satirical songs, they're trying to prevent us from demonstrating in the same manner that's successfully garnered media attention for our issues in the past," explained Mr. Delgaudio.

### Undeterred by the Left

Facing threats of arrest, Public Advocate demonstrated anyway, with a "Nancy Pelosi Sobriety Checkpoint" to prowl the streets for Nancy Pelosi, drunk with power.

Volunteers and Public Advocate staff performed "Wasting Away in MadamSpeakerVille," followed up with a short piece on Adam Schiff and his "Lyn' Whistleblower."

Both Voice of America and the Media Research Center reported on Public Advocate's demonstration.

"Not only did we take a stand for the First Amendment, we actually received positive coverage from the press," reported Mr. Delgaudio.

### Peaceful Protests in a Crowd of Chaos

Police were not anxious to attack friendly, pro-Family conservatives merely singing clever melodies.

In fact, police were stretched thin dealing with thousands of crazed, violent Leftists supporting the lawless impeachment of the President. Angry crowds surrounded the Public Advocate singers, slinging insults and threats.

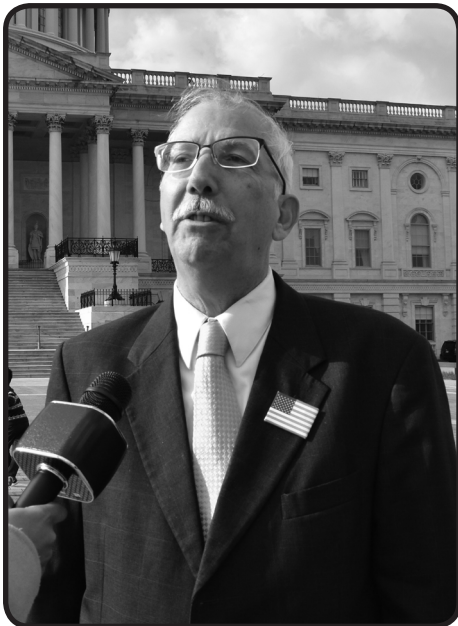
“They promote this legislation under the guise of equality, we’ve all seen where their so-called equality ends,” Eugene Delgaudio, president of Public Advocate explained.

Absurdly enough, they’re even counting states that retracted their ratification along with states that ratified the document after the sunset clause.

With the help of radical Leftists, the radical Homosexual Lobby has managed to pass this bill that would ratify the ERA in the House

“The only thing holding back the ERA is the strength of millions of Americans who believe in due process and Family Values.

We can’t let the leftist media elites and politicians dictate our beliefs, and we can’t let them define marriage,” stressed Mr. Delgaudio.

The Bladensburg case could have given the Left the legal authority to tear

down all memorial crosses across the country, opening the doors to a public ban on all Christian religious symbols.

Fortunately, thanks to the efforts of Public Advocate and its members, the Supreme Court overwhelmingly ruled that the Bladensburg Peace Cross Veterans' Memorial could not be torn down.

"As we say goodbye to 2019, I'm proud of the work Public Advocate has accomplished," explained Mr. Delgaudio.

That's why Public Advocate supporters banded together to deliver thousands of personalized Christmas cards to the President and First Lady.

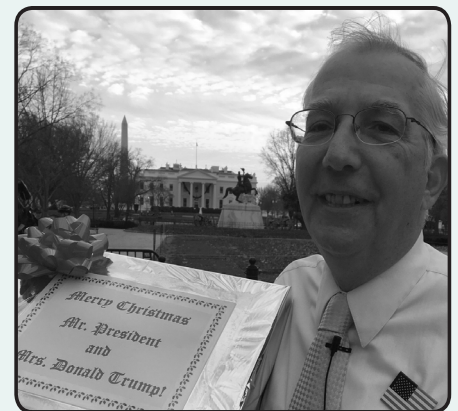
### **Supporting President Trump's Stand**

Whenever so-called “conservatives” try to “compromise” with the Homosexual Lobby and their radical activists, Americans lose Religious Liberty.

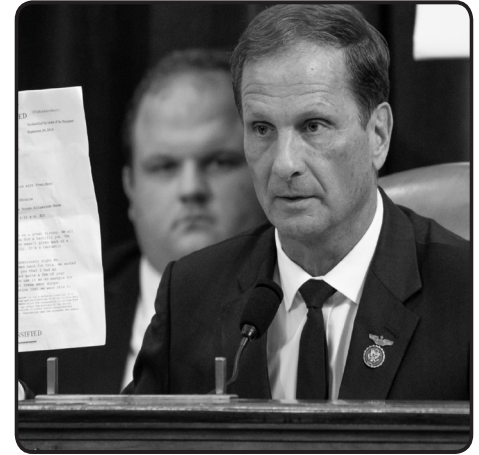
Mr. Delgaudio has vowed to stand in the gap, even when so-

### Anti-Christian Propaganda

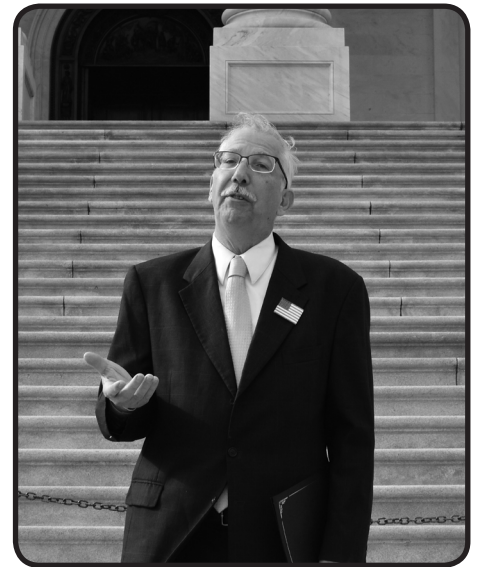
