This man still had years left to serve, yet Biden set him free.

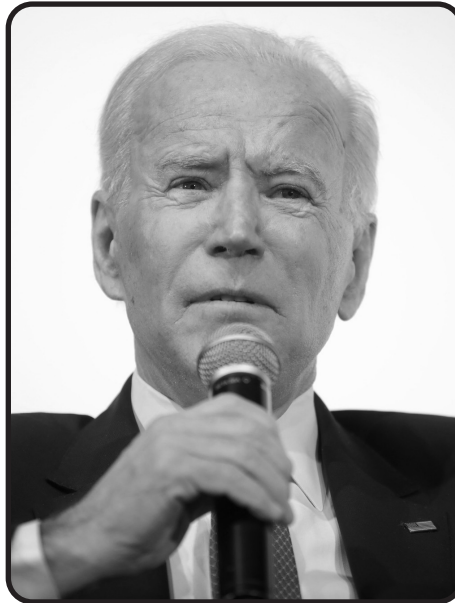
And with these pardons, Biden has sent a clear message that protecting criminals matters more than protecting Americans.

"Pro-Family have Americans received exactly what they were hoping for from Trump with this decision," exclaimed Mr. Delgaudio.

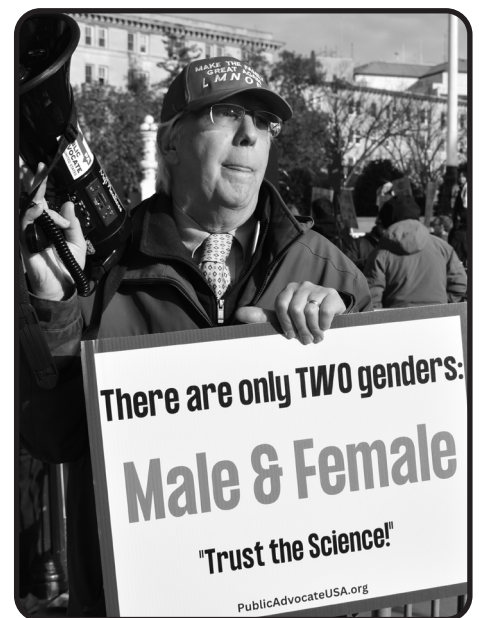

The Administration has also purged the majority of the funding that was being funneled to the Global Homosexual Agenda. He declared that the Federal Government would only acknowledge two God-given genders.

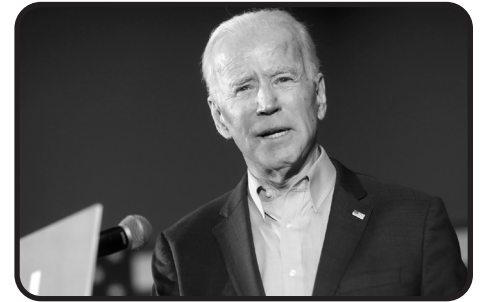
He terminated Biden's radical DEI programs, putting an end to divisive identity politics in schools.

This bill would grant special privileges to homosexuals and transgenders, effectively outlawing Traditional Values.

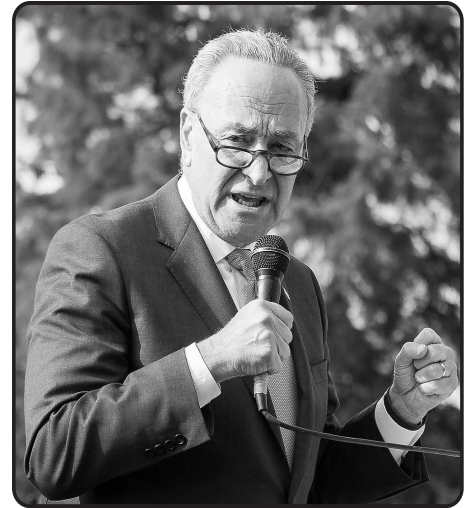
It would empower federal officials to punish those who refuse to comply even in churches and schools.

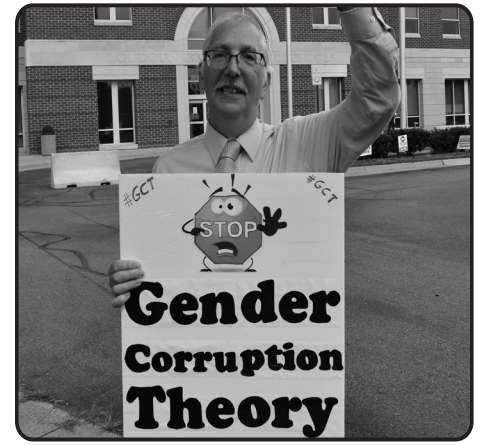
