Public Advocate Defends Life and Family More Than Ever



Public Advocate creates Legal Foundation to support President Trumps pro-Family agenda.

I'm thrilled to share a major development with you in our fight to defend President Trump and the pro-Family agenda: Public Advocate is now in court supporting President Trump's authority to lead the executive branch without interference from radical bureaucrats and activist judges.

We've officially filed an Amicus Brief (Friend of the Court) in the case *Wilcox v. Trump* (Case No. 25-5057).

This case involves Gwynne Wilcox, a Biden appointee to the

National Labor Relations Board, who is suing President Trump after being removed from her position.

Her claim? That President Trump didn't have the authority to fire her.

The implications are enormous. This case directly affects Trump's ability to enforce executive orders like the ones protecting women's sports under Title IX, ending federal promotion of gender ideology in schools, halting child sex-change procedures, deporting dangerous

Chief Justice Roberts Undermines Judicial Credibility

Public Advocate Warns of Activist Judges

In a sharp rebuke of Chief Justice John Roberts, Public Advocate President Eugene Delgaudio, has once again sounded the alarm about the Supreme Court's ideological drift and its dangerous consequences for the American Republic.

"Public Advocate opposed John Roberts for the Supreme Court from the beginning and warned he was a traitor who would stab America in the back," Mr. Delgaudio said.

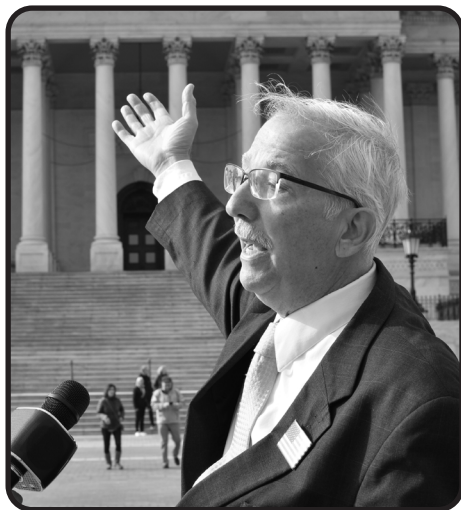
"Now, he sides with radical rogue federal judges to disrupt the Trump Administration on a daily basis.



Judge Roberts' Latest Remarks Signal Deepening Divide Over Separation of Powers

Mr. Delgaudio's comments come in the wake of Roberts' latest intervention -- a public critique of President Donald Trump for calling for the impeachment of District Court Judge James Boasberg.

Judge Boasberg, an Obama

appointee, attempted to block the deportation of Tren de Aragua gang members, a move the Trump Administration sees as a grave national security risk.

Roberts responded by stating, "For more than two centuries, it has been established that impeachment is not an appropriate response to disagreement concerning a judicial decision."

Critics argue that Roberts' selective interventions increasingly appear designed to shield liberal-leaning decisions while silencing conservative efforts to hold the judiciary accountable.

Questions Arise Over Roberts Motives

The pattern of public statements, often directed at Republican leaders or policies, raises concerns that the chief justice is prioritizing public

relations over constitutional fidelity.

However, questions have been raised about the chief justice's conduct.

The statement, oddly, was not posted to the Supreme Court's official website but was instead distributed to legacy media outlets.

Multiple requests by *The Federalist* CEO Sean Davis for the full statement and an explanation have gone unanswered.

Public Advocate Wary

Mr. Delgaudio further warned, "Chief Justice Roberts is protecting activist judges who are undermining the rule of law and dismantling the very foundation of justice in America."

As *The Federalist* notes, Roberts' repeated interference under the guise of preserving the judiciary's "legitimacy" is instead eroding public trust.

By shielding radical decisions and publicly chastising the executive branch, Roberts risks transforming the judiciary from an impartial arbiter into a political weapon. 🇺🇸

Fighting Back Against Injustice

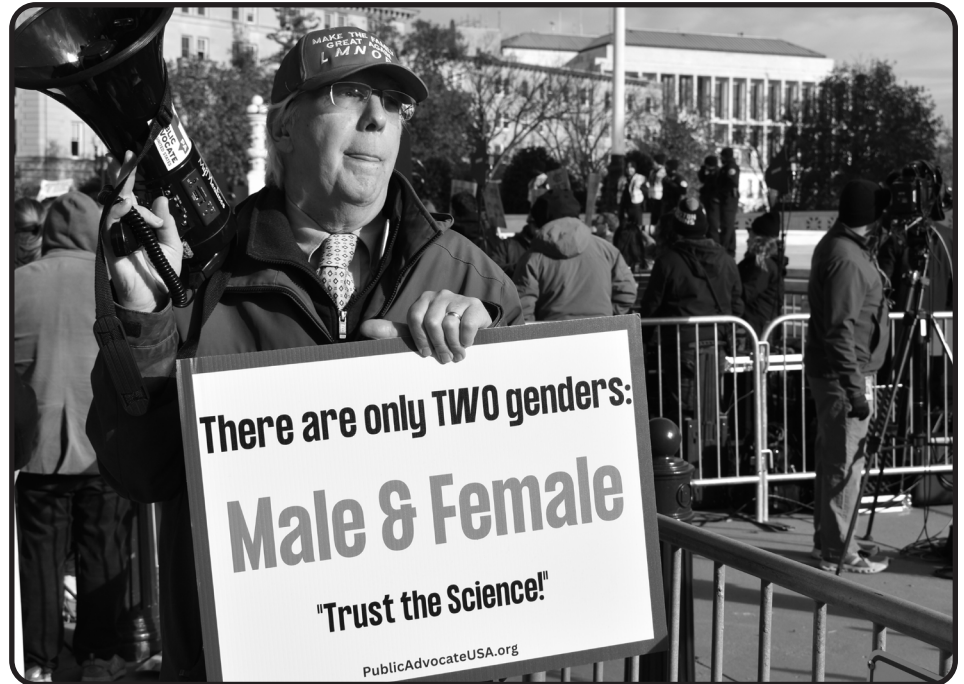
Two young women have stood up in recent days to fight back against this injustice.

Despite pressure to keep silent, they told their stories publicly.

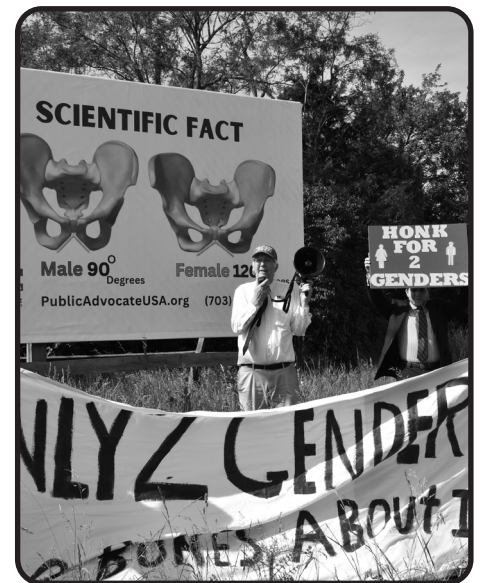

Each case represents a direct threat to the values we hold dear --

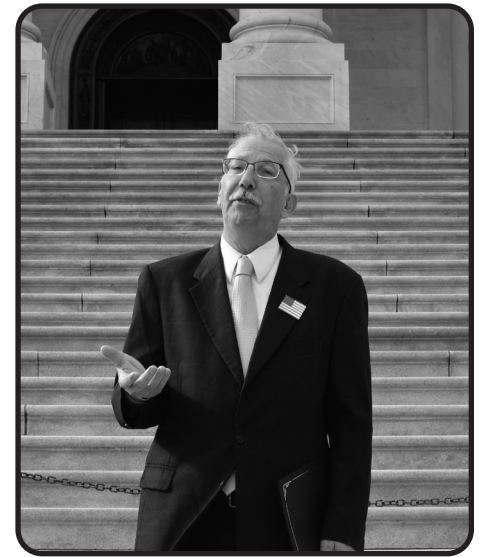
whether it's free speech, religious liberty, parental rights, or the biological truth of male and female. The courts have become a critical battleground, and we must fight more deeply and more decisively.

President Defunds Radical Homosexual Agenda

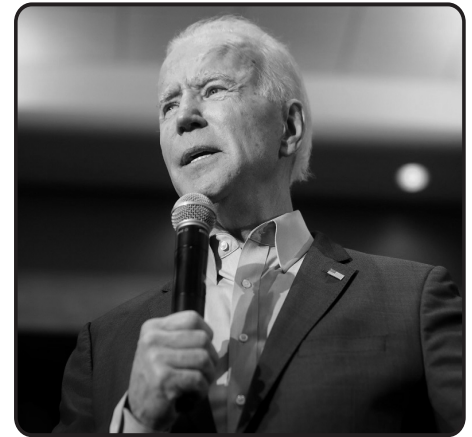
Public Advocate warns that many in Congress, including some Republicans, may fold under pressure.
