The Midterms: A Test for Pro-Family America

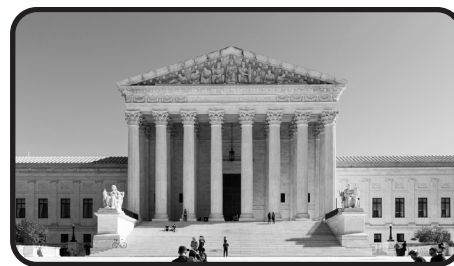

Fighting Cases from Coast to Coast

What started just over a year ago as an urgent effort to defend conservative Americans in the courts has rapidly grown into one of the most active pro-Family legal organizations in the country.

Public Advocate Foundation is now fully operational -- and already making a major impact nationwide.

In its first year alone, the Foundation has participated in dozens of legal actions and has filed an extraordinary number of amicus briefs in state and federal courts,

including cases now moving toward or decided by the United States Supreme Court.

Among the most important was *First Choice Women's Resource Centers, Inc. v. Platkin*, a major

New Jersey case involving donor privacy and free speech.

At issue was whether government officials can force Christian and conservative organizations to reveal confidential donor information -- potentially exposing supporters to harassment and intimidation.

Public Advocate Foundation quickly stepped forward to support the fight.

Public Advocate's Long War Against the Southern Poverty Law Center **Radicals at SPLC Busted Funding Hate Groups to Justify Itself**

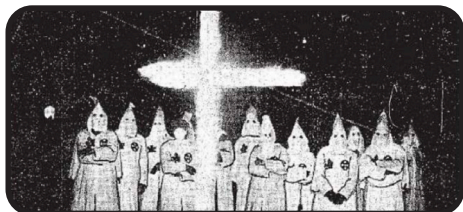
For years, Public Advocate has warned Americans that the Southern Poverty Law Center (SPLC) was not a “civil rights” organization but a Radical Left attack machine targeting Christians and pro-Family conservatives.

Now, after years of controversy, investigations and growing public scrutiny, the SPLC is finally facing mounting questions about its conduct and political operations.

According to an 11-count federal indictment released April 20, 2026, the so-called “civil rights group” defrauded donors by using their money to fund the very extremism it claimed to be fighting, with payments of at least \$3 million between 2014 and 2023 to people affiliated with the Ku Klux Klan, the United Klans of America, the National Socialist Party of America and other extremist groups.

Public Advocate President Eugene Delgaudio says the organization’s tactics are nothing new to him.

“The SPLC has recklessly and maliciously inspired terrorism against conservatives and Christians for decades -- all the while being given unprecedented access to the government, especially the Department of Justice,” explained Mr. Delgaudio.

Public Advocate President Eugene Delgaudio and the organization itself were publicly labeled a “hate group” by SPLC hacks who even published private information about Mr. Delgaudio, putting a bullseye target on his back.

SPLC Inspired Hate and Violence Against Delgaudio and Conservatives

Just months after Public Advocate appeared on the SPLC’s infamous “Hate Map,” a gunman carrying a printed copy of the list launched an attack targeting pro-Family organizations in Washington, D.C. and at Public Advocate’s headquarters.

“The Southern Poverty Law Center (SPLC) nearly got me and my staff gunned down by their deceitful ‘Hate Map.’ It was only by the protection of God that neither I nor my staff were hurt,” added Mr. Delgaudio.

The incident became one of the most widely discussed controversies surrounding the SPLC and its inflammatory, false accusations.

Public Advocate also points to recent reports and allegations involving questionable financial practices and the SPLC’s links to extremist organizations and activists.

“The Southern Poverty Law Center built a multi-hundred-million-dollar empire by demonizing Christians and conservatives,” Mr. Delgaudio said. *“Now the country is finally beginning to realize just how dangerous and reckless that strategy really was.”*

Public Advocate Will Never be Cowed by Threats of Leftist Violence

Public Advocate has spent years fighting back against what Mr. Delgaudio calls the SPLC’s “calls for terrorism” against conservative and Christian groups.

And according to Mr. Delgaudio, the organization’s influence inside government agencies and major corporations made it especially dangerous.

“They wanted banks to blacklist us, social media companies to censor us, and law enforcement to treat conservative Christians as extremists ... and the Biden Administration happily obliged,” Mr. Delgaudio stated. *“But Americans are finally starting to push back.”*

Public Advocate says the growing scrutiny surrounding the SPLC is an important victory for free speech and Religious Liberty -- and proof that determined grassroots activism can still expose powerful institutions that once seemed untouchable. 🇺🇸

Sage Blair's Story Becomes National Symbol for Parental Rights

Public Advocate Alerted Country to Young Girl's Plight

For years, Public Advocate warned Americans that radical gender policies in schools would endanger children and destroy parental rights.

Now, one young woman's heartbreaking story has become a national symbol of that fight.

Sage Blair was just 14 years old when school officials in Virginia began secretly "socially transitioning" her at school -- without her family's knowledge or consent. According to her family, teachers treated Sage as a boy, used different pronouns, and concealed the situation from her parents.

The situation spiraled into tragedy.

After running away from home, Sage was eventually trafficked and abused -- while Maryland officials refused to return her to her family because her parents would not affirm her "transition."

Public Advocate was among the first national organizations to publicly expose Sage's story and warn Americans about the dangers

of government-backed gender ideology targeting children.

Public Advocate's Involvement Sparks National Movement

"This should never happen in America," said Public Advocate President Eugene Delgaudio. *"Government bureaucrats and activist school staff tried to replace loving parents while pushing radical ideology onto a confused child."*

Today, Sage's story is helping drive major parental rights battles nationwide.

Earlier this year, President Donald Trump publicly recognized Sage during his State of the Union Address before Congress, calling attention to the dangers of schools that work to secretly transition children behind parents' backs.

Meanwhile, Public Advocate Foundation recently helped secure a major Supreme Court victory in *Mirabelli v. Bonta*, restoring protections for parents after California schools were caught secretly transitioning children without notifying families.

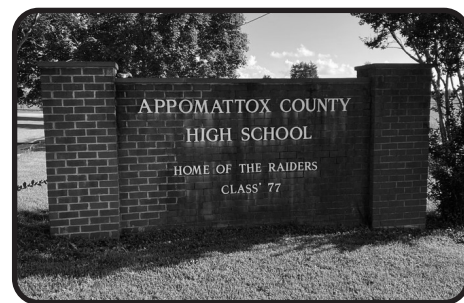


Public Advocate raised national awareness of Sage Blair's plight, in part through a national petition drive to Congress.

Public Advocate also helped build grassroots momentum behind the *Protect Children's Innocence Act* after more than 130,000 petitions were delivered to Congress supporting protections for minors.

Now 19 years old and attending Liberty University, Sage is publicly speaking out about her experience and urging Americans to protect parental rights and vulnerable children.

"Sage's courage is changing the national conversation," Mr. Delgaudio said. *"And Public Advocate will continue fighting until no child is ever put through something like this again."*

States Accused of Hiding Sex “Transition” Programs from Parents

Taxpayer Dollars Being Used to Circumvent the Law

Public Advocate Foundation is warning that taxpayer-funded schools and hospitals across America are continuing to push secret “gender transition” programs on children -- even after major court rulings protecting parental rights.

Radical activists inside school systems, children’s hospitals, and government agencies are still working to socially transition minors behind parents’ backs, while treating mothers and fathers as obstacles to be removed.

“This is one of the greatest betrayals of parental rights in modern American history,” stated Public Advocate President Eugene Delgaudio. *“Government-funded institutions are actively hiding life-altering decisions from parents, while radical activists try to normalize permanent harm to children.”*

Hospital Administrators Call for Parents to Be Arrested

Public Advocate Foundation points to growing evidence that schools and hospitals have trained staff to conceal gender identity issues from families. In some cases, parents opposing so-called “gender-affirming care” have even faced investigations or accusations of abuse.

At Children’s Mercy Hospital in Kansas City, Missouri, a Big Pharma-funded “expert” claimed that parents “refusing puberty-blocking treatment” are committing “psychological harm,” which she equated with physical abuse that should be subject to criminal prosecution.

The Children’s Hospital in Philadelphia has trained hundreds of medical professionals over the last five years on how to keep gender identity procedures from parents.

Public Advocate Foundation Provides Key Legal Backing

Meanwhile, Texas Attorney General Ken Paxton recently secured a major court victory against Texas Children’s Hospital after allegations the hospital continued transgender transition procedures on minors despite state restrictions.

Public Advocate Foundation’s research and legal work shaped many of the arguments now being used in courts nationwide.

Public Advocate Lone Voice Defending Parental Rights

“When others stayed silent,

Public Advocate stood up and exposed what was happening to children,” Mr. Delgaudio said. *“Now even the courts are beginning to recognize how dangerous and deceptive these policies really are.”*

Public Advocate Foundation is currently monitoring legal battles in multiple states, including California, Wisconsin, Washington State, and New York, where activists continue to push policies designed to keep parents in the dark.

Public Advocate Foundation warns that despite recent Supreme Court victories, many state officials are resisting compliance and attempting to preserve secret “transition” systems inside schools and hospitals.

“Parents are waking up,” Mr. Delgaudio warned. *“And Public Advocate Foundation intends to keep fighting until every parent in America once again has the right to know exactly what government officials are doing with their children.”* 🌱

Every race matters, every seat matters, and every victory gives pro-Family Americans more room to fight and more power to end the radical LGBT agenda.

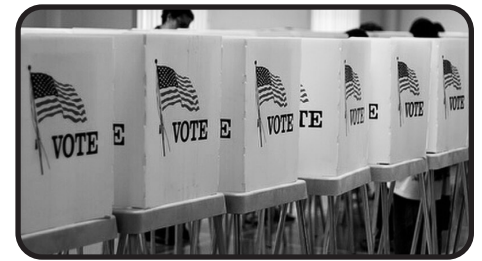

Public Advocate Stands with Texans in Supreme Court Pornography Case

Tremendous Supreme Court Victory for Public Advocate Foundation

Public Advocate Foundation scored a major victory for families and children after standing alongside Texas Attorney General (and now Republican nominee for the U.S. Senate) Ken Paxton in the landmark Supreme Court case *Free Speech Coalition, Inc. v. Paxton*.

The case centered on whether online pornography websites could be required to verify the age of users before exposing children to explicit material.

While many organizations refused to get involved in the politically-charged battle, Public Advocate stepped forward and filed in support of Texas and the protection of minors.

“When everyone else was afraid

to stand up and be counted, Public Advocate stood with Ken Paxton all the way to the Supreme Court,” said Public Advocate President Eugene Delgaudio. “Protecting children from online predators and pornography should not be controversial in the United States of America.”

Public Advocate Foundation Efforts Felt Nationwide

The legal victory is already having a nationwide impact. Today, 23 states have enacted age-verification protections designed to prevent children from accessing dangerous online pornography sites.

“For years, Public Advocate warned America that children were being targeted by a multi-billion-dollar online pornography industry,” Mr. Delgaudio explained. “Now the country is finally waking up to just how dangerous and destructive this material really is.”

This victory demonstrates just how quickly Public Advocate Foundation has made an impact on the American legal system. 🇺🇸

“The Radical Left wants to punish and silence organizations simply for defending faith, family, and traditional values,” said Public Advocate President Eugene Delgaudio. *“Public Advocate Foundation was created specifically for moments like this.”*

The Foundation has also participated in major legal battles involving parental rights, online pornography protections for children, Religious Liberty, free speech, and fairness in women’s sports.

Mr. Delgaudio said the overwhelming number of legal

threats facing conservative Americans today made the Foundation necessary.

“When we launched Public Advocate Foundation, I knew there would be important legal battles ahead,” Mr. Delgaudio explained. *“But even I never imagined just how many families, churches, counselors, parents, and conservative organizations would suddenly find themselves dragged into court.”*

Schools Hide Kids’ Transition from Parents

Supreme Court Sides with Parents in California “Transition” Case

Public Advocate Foundation Takes Gavin Newsom Head-On

Public Advocate Foundation is celebrating a major victory for parental rights after the Supreme Court ruled against California’s policy of secretly “transitioning” children at school without informing parents.

In the case *Mirabelli v. Bonta*, the Supreme Court voted 6-3 to restore an injunction blocking enforcement of California’s controversial secrecy policy. Public Advocate Foundation filed briefs supporting the parents and teachers challenging the law.

Under Governor Gavin Newsom, schools conspired to “transition” children behind parents’ backs, including pushing surgeries that leave children maimed for life and changing names and pronouns.

“This was the government deliberately lying to parents,” said Public Advocate President Eugene Delgaudio. *“The Supreme Court sent a powerful message that schools do*

not own America’s children.”

Under California law, schoolteachers and administrators can decide to “gender transition” any child they want to -- and keep it secret from the children’s parents -- but the Court sided with parents on Free Exercise and Due Process grounds, dealing a significant blow to radical Left-wing activists.

Public Advocate Foundation Warns the Fight Is Far from Over

Despite the ruling, Public Advocate says California officials have still failed to issue clear statewide guidance forcing school districts to comply with the Court’s decision.

“Gavin Newsom is dragging his feet while school systems continue pushing radical gender ideology on children,” Mr. Delgaudio warned. *“Parents deserve transparency, not secrecy and manipulation.”*

This victory comes just after

Public Advocate Foundation unleashed a grassroots pressure campaign and delivered more than 130,000 petitions to the House of Representatives, demanding passage of the *Protect Children’s Innocence Act* banning gender procedures on minors.

Meanwhile, Public Advocate Foundation is now preparing additional legal action and monitoring similar cases nationwide.

“This battle is about whether parents or government bureaucrats will raise America’s children,” Mr. Delgaudio concluded. *“And Public Advocate intends to keep fighting until parents win.”* 🇺🇸
